What we've been doing

8 January 2019

Westmorland Park

We coppiced hazel, continuing along the path from where we had worked at a previous task (13/11/18). The brash was burnt on a bonfire, and some material was saved as hedging posts and binders. A householder living locally had expressed some concern about losing cover for her boundary fence, so in the afternoon we constructed a dead hedge to screen part of the fence.

The weather was sunny and quite warm.

We had a record turnout of 25 volunteers: in 2017 and the first half of 2018 we were averaging 10-12 volunteers on a good day; there seems to have been an influx of new volunteers from about the start of July 2018. This is very good news for the group.

15 January 2019

Frog Copse

We cleared holly and laurel on the Downshire Way side of the site, leaving a screen of trees adjacent to the side of the road. The impending widening of Downshire Way will probably mean that these trees will be cleared anyway. Cleared material was burnt on a bonfire. The BFC ranger trailered in some more material, mostly holly, from Bill Hill, which was also burnt. Parking was easier than expected in this small street.

We had a very good turnout of 22 people.

The weather was cloudy and mild, with a slight northerly breeze.
