What we've been doing

5 February 2019

Hayley Green Woods

One group removed brambles from beneath trees, using forks. The aim was to remove the bramble roots as thoroughly as possible, to prevent regrowth. Cleared material was burnt on a bonfire. A toad and a frog with only 1 back leg were rescued from the site. The frog appeared to be coping very well.

Other volunteers dug out a stream to create 2 ponds. A dam was constructed from logs and earth, using only materials available on site. The dam was very effective.

The weather was relatively mild, about 6°C, but overcast. A close to record turnout of 24 volunteers attended.

12 February 2019

Wildmoor Heath

The site was an area of heathland which had been cut before. The group removed encroaching scrub, mostly gorse and some Scots pine. There were large numbers of pine seedlings invading the cleared area. The BFC ranger cut down some mature heather plants using a strimmer. A red admiral butterfly was seen basking.

There was a good turnout of 18 people. The weather was relatively mild with some sunshine.

New horizon elm

Woolley Firs is a nature reserve run by the Berkshire, Buckinghamshire and Oxfordshire Wildlife Trust (BBOWT). Two members of BCV, on a walk through the reserve, report that elm has been planted in Robin Hood's Arbour, with the aim of encouraging the rare white-letter hairstreak butterfly. The elm is of the "new horizon" variety, which is resistant to Dutch elm disease. The elm was planted in a clearing which had been created, with wild ivy left standing on the trees. See:
